I - SEMINAR OBJECTIVES AND PROGRAMME

The PIC/S Seminar is part of PIC/S continuous training programme in the field of Good Manufacturing Practice (GMP). It is open to inspectors from the PIC/S Participating Authorities, Observers and invited guests.

The objectives of the 2003 Seminar are:

- (i) to provide a forum for expert discussions on current regulatory issues related to GMP in pharmaceutical quality control laboratories;
- (ii) to harmonise inspection standards and practices; and
- (iii) to issue guidance documents in this field.

It is expected that both workshops and discussions between the GMP and GLP inspectors will result in an Aide Memoire on the inspection of pharmaceutical quality control laboratories.

Session I aims at presenting how PIC/S, the EU/EMEA, the OECD, FDA and WHO regulate quality control laboratories and Good Laboratory Practice (GLP).

Session II focuses on specific aspects in the pharmaceutical quality control laboratories such as use of the reference standards, validation, batch release, qualified person and microbial monitoring.

In Session III aspects related to the GMP inspection of the pharmaceutical quality control laboratories (such as sampling and testing of APIs, failure investigation, handling of results, investigation of equipment and documentation) will be discussed both in the plenary and in workshops. There will be four workshops on the preparation of the Aide Memoire, microbial monitoring, validation and documentation. The objectives of the workshops are as follows:

- > To prepare a draft Aide Memoire on the inspection of pharmaceutical quality control laboratories:
- > To identify critical failures usually found in laboratories;
- > To exchange inspectors' experiences.

Session IV of the Seminar will report on the workshops and the elements of the draft Aide Memoire. Future trends and development in the field of pharmaceutical quality control laboratory practice will also be presented.
